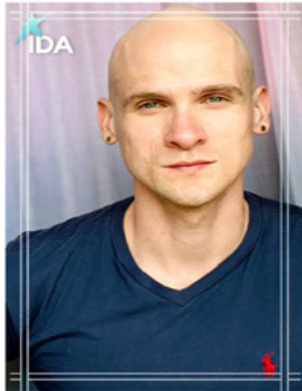




## JUDGES - PITTSBURGH, PENNSYLVANIA

Paul studied dance with the Northeast Atlanta Ballet and Gwinnett Ballet Theatre and went on to complete his BFA in Musical Theatre with a minor in Dance from Western Carolina University under the direction of Broadway veteran, Terrence Mann. For the past eight years, Paul has been working as a performer, dance captain, swing, teacher, and creative collaborator.
